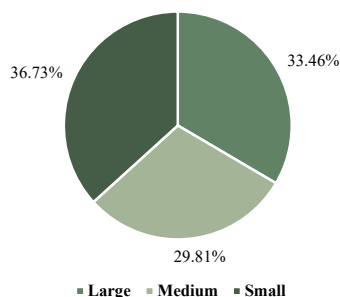
Investment Strategy

The Archer Multi Cap Fund seeks long-term growth of capital by investing in up to 100 equity positions split evenly between the top 25 small, medium, and large publicly traded, US companies at the beginning of each calendar year based on market capitalization. Position sizes are adjusted throughout the year driven by our proprietary quantitative and technical models and rebalanced annually.

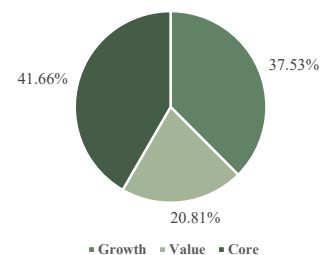

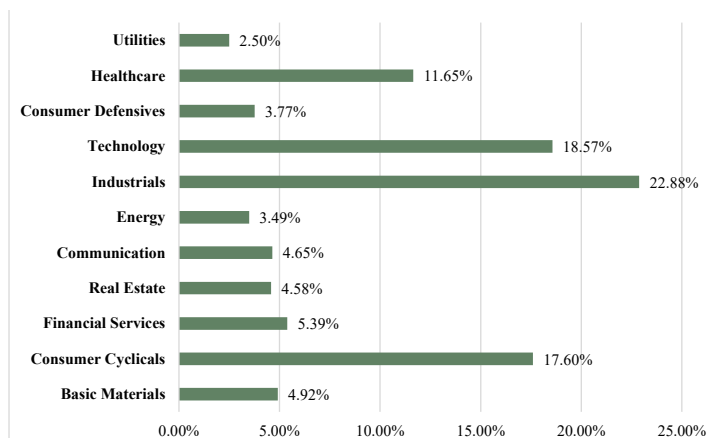
Equity Capitalization
