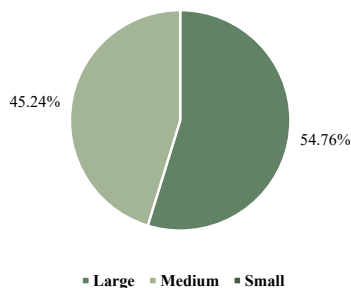
## Investment Strategy

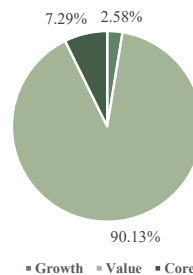

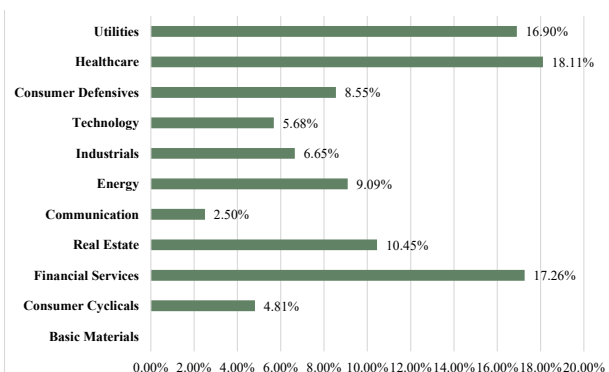
### Equity Capitalization
