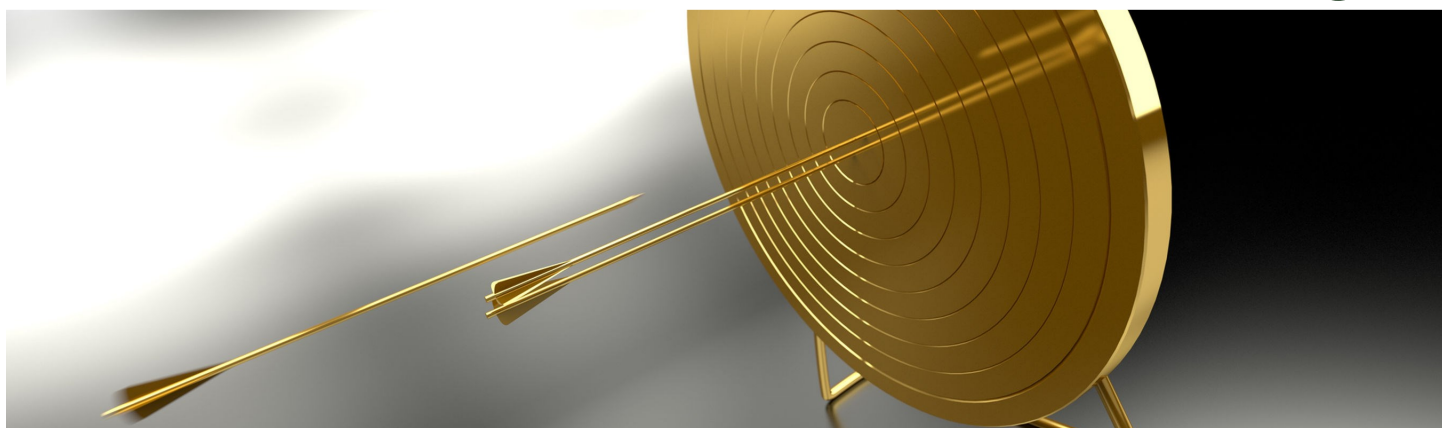

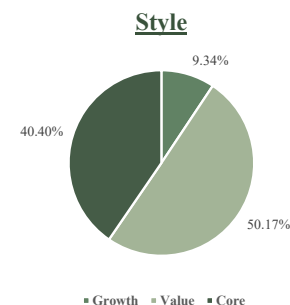
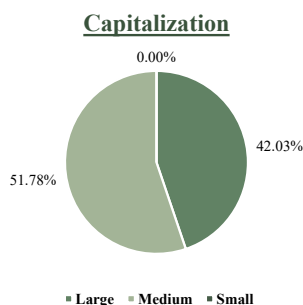

Investment Strategy

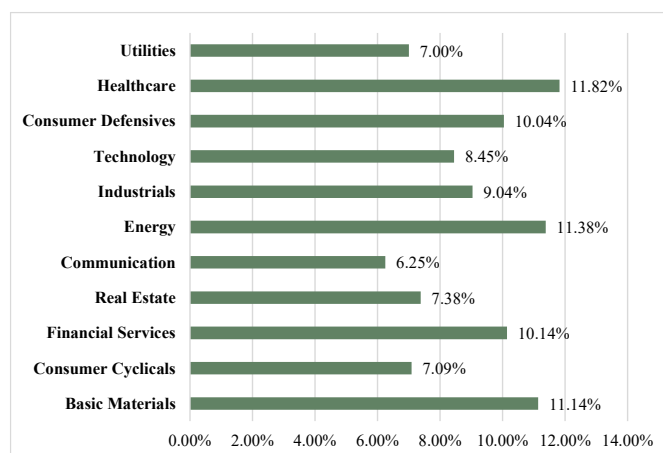
