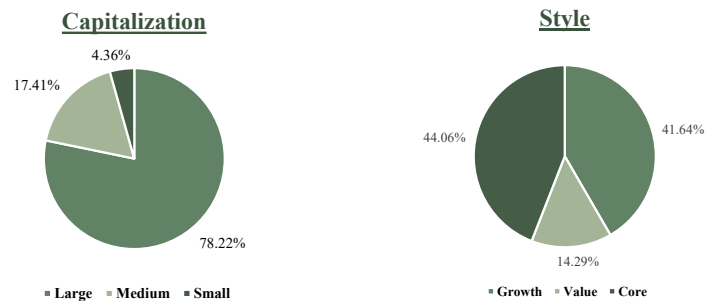

Investment Strategy

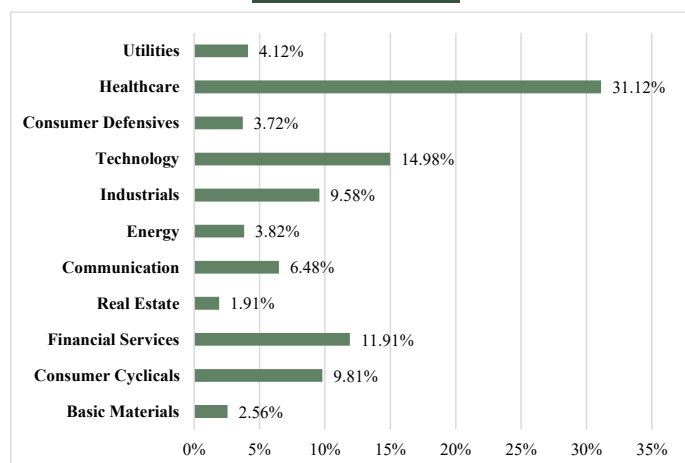
