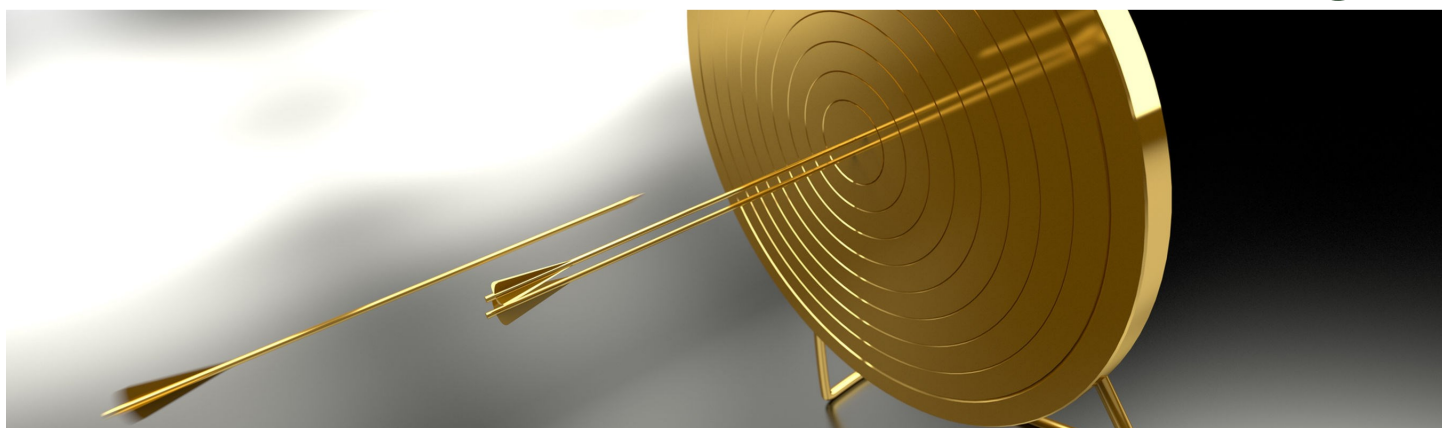

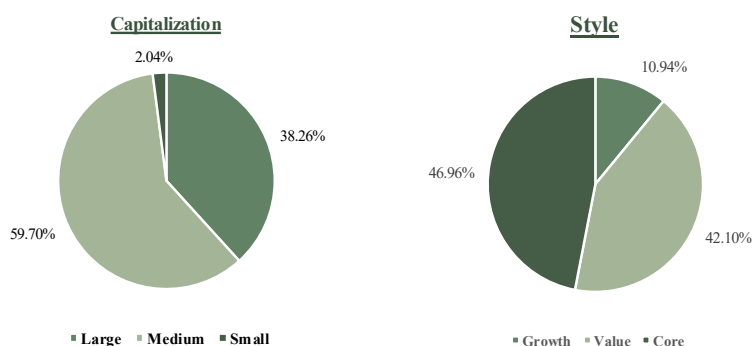

Investment Strategy

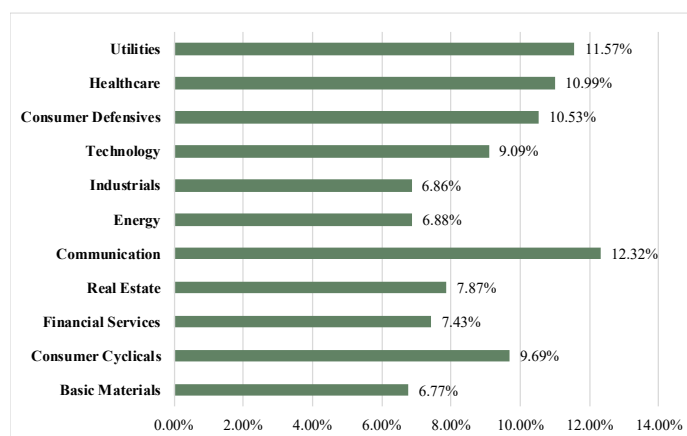
