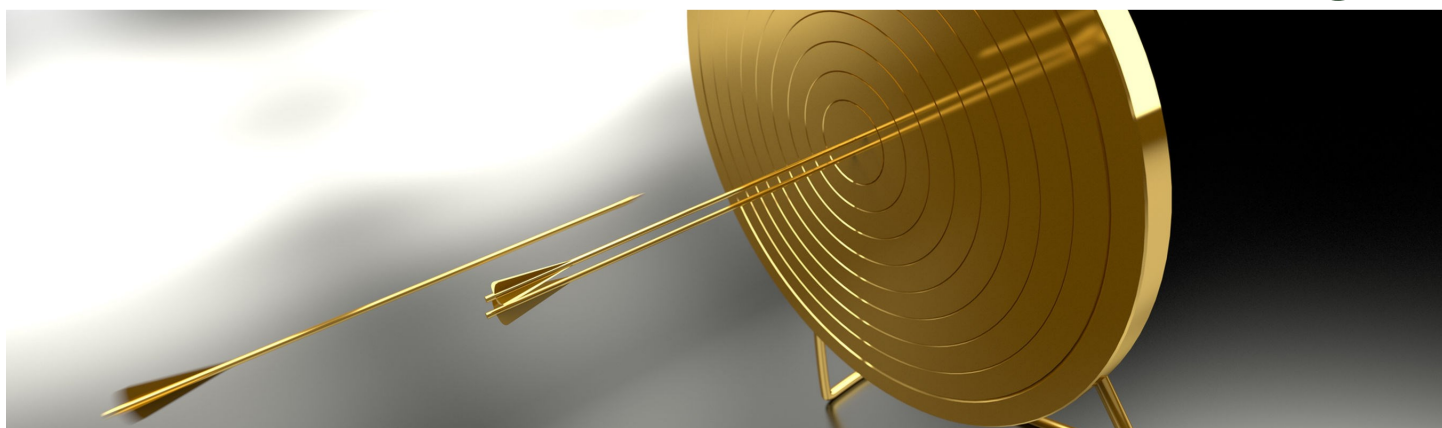

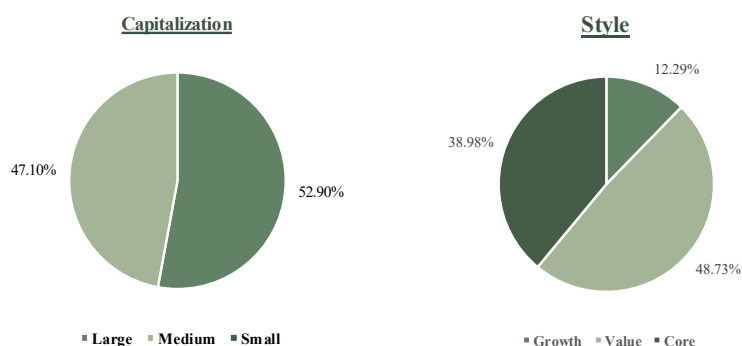

Investment Strategy

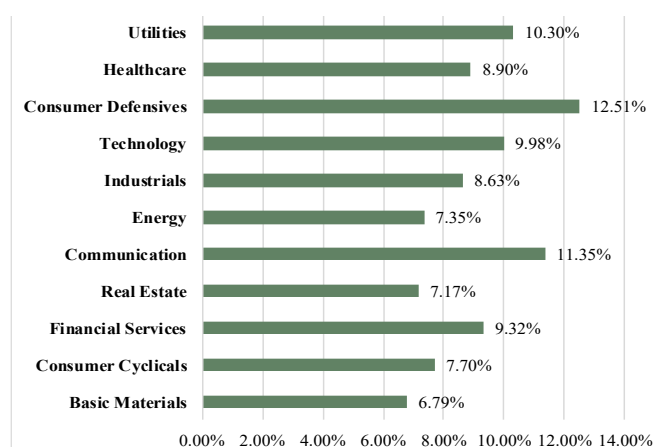
